Both are ADA compliant. MaryAnn Devries is applying for a grant from the same group as last year.

PARKS REPORT; PARKS MANAGER- TK Pence

- 1. A new modem has been placed at the Gull Lake gate for entry. It is under evaluation.
- 2. Wayne Burdo has stated he cannot mow around the wash station when vehicles are parked so close. TK will address the issue.
- 3. Pickle Ball Courts are ready to go.
- 4. The volley ball pit needs to be cleaned up and the nets placed.
- 5. The baseball field was/needs weeds addressed. It was sprayed but not good results.
- 6. The playground needs mulch. The company has been contacted, their truck is down at present.
- 7. The Memorial Day Parade is on for Monday. The Municipal Park will be cleaned up.
- 8. Gull Lake Overflow
 - The rules have been posted on the website.
 - The sandwich board for at the entrance should be ready this weekend.
 - A suggestion was made to pull the 3 in line to be admitted to the staging area to await their launch.
 - Will see how this weekend goes.
- 9. The trailer that has been budgeted needs to be purchased. TK will purchase after speaking with the Treasurer.
- 10. There is discussion with Mark D Doster and TK Pence as to cementing the garage floor.
- 11. TK has researched the recycling of returnables at Gull Lake. Containers were discussed. A grant is also available through Barry County Recycling.

Cameras

Two [2] Vendors have been approached for cameras for UCL and GL to monitor for violators, vandalism, and safety needs.

Traffic Safety and Vigilon Security are the vendors to send us cameras for a trial.

Cloud storage will be used.

The cameras may allow for posting live the parking lots for the public to view at the website to Determine how full the lots are and waiting time.

We have replaced 6 gates in the last month, 4 in a week. The gate replacements are \$350 each with \$300 for shipping.

We will be looking for a decision on the camera purchases at the June meeting.
