

**PRAIRIEVILLE TOWNSHIP
PARKS AND RECREATION ORDINANCE NO. 152, SECTION III**

Park Usage Rules

1. **Prairieville Township Parks and Recreation Commission shall establish and change site entry fees, parking fees and fees for launching/retrieving a boat. Fees are to be paid by Township residents and nonresidents. Fees paid at each site are good only at that site. Annual passes are good at all sites.**
2. **Payment of entry fee is to be made immediately upon entry. Payment upon re-entry is required. Annual passes may be used for park entry and re-entry.**
3. **No one shall enter or remain in a Township site during closing times.**
4. **No one shall dispose of refuse except in receptacles provided and only refuse resulting from use of premises.**
5. **No one shall obstruct the free passage of other persons.**
6. **Written permission is required to post signs, distribute commercial advertising, erect a fence, barrier or construct or occupy an improvement on the premises. No placard, bill, notice or sign can be posted/paste/fastened or affixed except temporary directional signs which must be removed.**
7. **No one shall injure, destroy, damage, mutilate, move or remove any vegetation, building, fence, picnic table, equipment or other improvement.**
8. **No one shall possess, use or distribute a "controlled substance" anywhere on the premises or consume alcoholic beverages in any area other than a designated area/**
9. **No one shall hunt, trap or disturb any bird or animal on the premises without permission. Fishing is permitted in designated areas.**
10. **No one shall swim in any designated boat launching area.**
11. **Use of profane/obscene language is prohibited. Persons will conduct themselves in an orderly manner.**
12. **Baseball or softball shall be played only in designated areas.**
13. **Any device that generates sound may not be played at a volume which disturbs other persons.**
14. **No person shall engage in any violent/abusive/boisterous/loud/illegal/obscene or similarly disorderly conduct which interferes with the use of the premises by others..**
15. **Vehicles must be parked in designated parking spaces in such a manner that only one parking space is utilized. Vehicles are to be driven only in designated driving lanes and parking areas.**
16. **No one shall camp or park recreational vehicles on the premises overnight.**
17. **Maximum permitted vehicle speed on Township property (unless otherwise posted) is twenty-five miles per hour.**

- 18 Washing/polishing/repairing motor vehicles is prohibited unless otherwise authorized.
19. Persons may operate motorized devices on the premises unless otherwise designated.
20. A boat, boat trailer, vehicle, duck blind, ice shanty, raft or other property cannot be stored or left during closing hours. Vehicles are subject to towing.
21. "Powering" off or on is strictly prohibited.
22. No vessel shall be docked, moored or anchored overnight on Township lands or located within 250 feet of the shoreline of a Township park or access area.
23. Flying powered toys are permitted unless otherwise designated.
24. Food may be cooked on grills provided. Other cooking grills/containers/open or ground fires are prohibited.
25. Cooking grills and picnic tables should not be held for longer than necessary.
26. No one shall bring or use any unlawful firearm or illegal weapon upon the premises.
27. No one shall possess/bring/use explosive materials including any type of firework on the premises.
28. Only a law enforcement officer or person licensed to carry a concealed weapon may possess/bring/use any device which discharges projectiles on the premises.
29. A dog or other pet brought onto the premises must be on a leash no greater than 6 feet maximum in length, kept under control at all times and, with the exception of a service dog, is not allowed in playground areas, park buildings, beach or swimming areas or other so designated areas. Feces must be picked up and placed in a waste container immediately. Excessive noise by the animal is prohibited.
30. Horses, riding animals, pack animals or any such animals or animal-drawn vehicles may only use or travel on designated roads or trails unless written permission to use other areas has been obtained.
31. Prior written permission must be obtained to use the premises for business or commercial purposes or for any special event or activity. Such permission may be granted with or without conditions or may be denied.
32. Fees may be charged for the issuance of a permit.
33. Any fishing tournament or competition regardless of the number of participants is considered to be a special event or activity for which a permit is required.
34. Any fishing tournament or competition beginning prior to 9:00 a.m. shall employ an event starting method that creates a minimal noise level and a minimal wake.
35. A permit may be waived if it is determined that the special event or activity will not require oversight and will have minimal impact on the use of the site by others.
